## **GOVERNMENT DEGREE COLLEGE, THEOG**

### An Overview

he scenic mountain town of Theog is situated at an hour's drive from Shimla, the capital of Himachal Pradesh. The NH-22 meanders and climbs up the hill ranges, covering a distance of 32 kms from Shimla, before it reaches this eye-catching locale. The town has a population of about 9000 and the main occupation of the natives is agriculture/horticulture. The magnificent vista of snow-clad Himalayas provides a majestic background to the town. The crisp mountain air is scented with pine and cedar, which abound in the area. In this poetic setting, at the highest point of the town, atop 'Chundu Hill', is situated the temple of learning, the Government Degree College, Theog.

The college was established in 1998, vide Notification No EDN-A-Chha (15)-13/97 dt 11-12-97 of the Government of Himachal Pradesh, as a co-educational institution. The first academic session commenced in the year 1999 with admissions to the first year of the threeyear degree course. Teaching commenced with a modest strength of about 100 students. The Science and Commerce Faculty were introduced in the session 2002-03. Today, the college has about 1100 students on its rolls. The college has been a great boon for the girls living in Theog and its surrounding areas. Earlier parents were reluctant to send their daughters to the far-off colleges at Shimla. Theog College has been a blessing for them and has really improved female literacy in this region. The fledgling college started functioning in the building of a former primary school. The college has been assessed and accredited by NAAC with Grade 'B'. The imposing facade of the present complex and related infrastructure came up in 2006. The college has an adequate number of classrooms, one common room for girls, science laboratories, one language laboratory, one conference hall and two computer laboratories having internet facilities. The campus is Wi-Fi enabled. The college library is very well-stocked and includes a large reading room with computer facility. The college has always worked towards the all-round development of its students and lays special emphasis on sports and extracurricular activities. Some add-on/selffinancing/skill courses are also planned as soon as Government approval is received.

Recently, Government College Theog celebrated its Silver Jubilee year. The institution takes pride in shaping the raw and energetic youth into educated and responsible citizens. The steadfast objective of this institution of higher learning is to impart quality education, with the constant efforts of its dedicated faculty.

# NEW CHOICE BASED CREDIT SYSTEM (CBCS) COURSES OF STUDY

Note: Executive Council of Himachal Pradesh University has approved the adoption of New CBCS of UGC on 30/05/2016 from 2016-17 academic session and adoption of Annual System w.e.f. 2018-19.

#### Advantages of the Choice Based Credit System (CBCS):

- -Shift in focus from the teacher-centric to student-centric education.
- -Student may undertake as many credits as they can cope with (without repeating all courses in a given semester if they fail in one/more courses).
- -CBCS allows students to choose inter-disciplinary, intra-disciplinary courses, skill-oriented papers (even from other disciplines according to their learning needs, interests and aptitude) and more flexibility for students).
- -CBCS makes education broad-based and at par with global standards.
- -CBCS offers flexibility for students to study at different times and at different institutions to complete a course (ease mobility of students). Credits earned at one institution can be transferred to another institution.

#### **CHOICE BASED CREDIT SYSTEM (CBCS):**

The CBCS provides an opportunity for the students to choose courses from the prescribed courses comprising core, elective and skill-based courses. The courses can be evaluated following the grading system, which is better than the conventional marking system. Therefore, it is necessary to introduce uniform grading system in the entire higher education in India. This will benefit the students to move across institutions both within India to begin with and across countries. The uniform grading system will also enable potential employers to assess the performance of the candidates. To bring uniformity in evaluation system and computation of the Cumulative Grade Point Average (CGPA) based on student's performance in examinations, the UGC has formulated some guidelines to be followed:

#### **Outline of Choice Based Credit System:**

- 1. Core Course: A course which should compulsorily be studied by a candidate as a core requirement is termed as a Core course.
- **Elective Course:** Generally, a course which can be chosen from a pool of courses and which may be very specific or specialized or advanced or supportive to the discipline/ subject of study or which provides an extended scope or which enables an exposure to some other discipline/subject/domain or nurtures the candidate's proficiency/skill is called an Elective Course.
- **2.1 Discipline Specific Elective (DSE) Course:** Elective courses which may be offered by the main discipline/subject of study is referred to as Discipline Specific Elective. The University/Institute may also offer discipline related Elective courses of interdisciplinary nature (to be offered by main discipline/subject of study).
- **2.2 Dissertation/Project:** An elective course designed to acquire special/advanced knowledge, such as supplement study/support study to a project work, and a candidate studies such a course on his own with an advisory support by a teacher/faculty member is called dissertation/project.
- **2.3 Generic Elective (GE) Course:** An elective course chosen generally from an unrelated discipline/subject, with an intention to seek exposure is called a Generic Elective.
- P.S.: A core course offered in a discipline/subject may be treated as an elective by other discipline/subject and vice versa and such electives may also be referred to as Generic Elective.

- **3. Ability Enhancement Courses (AEC):** The Ability Enhancement (AE) Courses may be of two kinds: Ability Enhancement Compulsory Courses (AECC) and Skill Enhancement Courses (SEC). "AECC" courses are the courses based upon the content that leads to Knowledge enhancement: (i) Environmental Science and (ii) English/MIL Communication. These are mandatory for all disciplines. SEC courses are value based and/or skill-based and are aimed at providing hands-on-training, competencies, skills, etc.
- 3.1 Ability Enhancement Compulsory Courses (AECC): Environmental Science, English Communication/MIL Communication.
- 3.2 Skill Enhancement Courses (SEC): These courses may be chosen from a pool of courses designed to provide value-based and/or skill-based knowledge.

#### \* Introducing Research Component in Under-Graduate Courses

Project Work/Dissertation is considered as a special course involving application of knowledge in solving/ analyzing /exploring a real-life situation / difficult problem. Project/Dissertation work would be of 6 credits. Project/Dissertation work may be given in lieu of a discipline specific elective paper.

#### **Implementation:**

- 1. The CBCS may be implemented in Central/State Universities subject to the condition that all the stakeholders agree to common minimum syllabi of the core papers and at least follow common minimum curriculum as fixed by the UGC. The allowed deviation from the syllabi being 20 % at the maximum.
- 2. The universities may be allowed to finally design their own syllabi for the core and elective papers subject to point no. 1. UGC may prepare a list of elective papers, but the universities may further add to the list of elective papers they want to offer as per the facilities available.
- 3. The number of Core papers for all Universities must be same for both UG Honors as well as UG Program.
- 4. Credit score earned by a student for any elective paper must be included in the student's overall score tally irrespective of whether the paper is offered by the parent university (degree awarding university/institute) or not.
- 5. For the introduction of AE Courses, they may be divided into two categories:
  - a) AE Compulsory Courses: The universities participating in CBCS system may have common curriculum for these papers. There may be one paper each in the 1<sup>st</sup> two semesters viz. (i) English/MIL Communication,
  - (ii) Environmental Science.
  - b) Skill Enhancement Courses: The universities may decide the papers they may want to offer from a common pool of papers decided by UGC or the universities may choose such papers themselves in addition to the list suggested by UGC. The universities may offer one paper per semester for these courses.
- 6. The university/Institute may plan the number of seats per elective paper as per the facility and infrastructure available.
- 7. An undergraduate degree with Honours in a discipline may be awarded if a student completes 14 core papers in that discipline, 2 Ability Enhancement Compulsory Courses (AECC), minimum 2 Skill Enhancement Courses (SEC) and 4 papers each from a list of Discipline Specific Elective and Generic Elective papers respectively.
- 8. An undergraduate Program degree in Science disciplines may be awarded if a student completes 4 core papers each in three disciplines of choice, 2 Ability Enhancement Compulsory Courses (AECC), minimum 4 Skill Enhancement Courses (SEC) and 2 papers each from a list of Discipline Specific Elective papers based on three disciplines of choice selected above, respectively.

- **3.** Ability Enhancement Courses (AEC): The Ability Enhancement (AE) Courses may be of two kinds: Ability Enhancement Compulsory Courses (AECC) and Skill Enhancement Courses (SEC). "AECC" courses are the courses based upon the content that leads to Knowledge enhancement: (i) Environmental Science and (ii) English/MIL Communication. These are mandatory for all disciplines. SEC courses are value based and/or skill-based and are aimed at providing hands-on-training, competencies, skills, etc.
- 3.1 Ability Enhancement Compulsory Courses (AECC): Environmental Science, English Communication/MIL Communication.

An undergraduate Program degree in Science disciplines may be awarded if a student completes 4 core papers each in three disciplines of choice, 2 Ability Enhancement Compulsory Courses (AECC), minimum 4 Skill Enhancement Courses (SEC) and 2 papers each from a list of Discipline Specific Elective papers based on three disciplines of choice selected above, respectively.

#### Note

- i) The candidates/applicants selecting/choosing their Core Course (DSC-I) from Group-I will select/choose the other Core Course (DSC-II) from Group-II or Group-III
- ii) Similarly, if candidates/applicants choose/opt their Core Course (DSC-I) from Group-II, they will choose/opt the other Core Course (DSC-II) from Group-I or Group-III
- iii) Likewise, if applicant choose/opt their Core Course (DSC-I) from Group-III, they will choose the other Core Course (DSC-II) from Group-I or Group-II.
- iv) In arts stream a candidate may opt only one practical and only one Language subject as core course (DSC)
- v) The maximum seats in each subject will be 80 in Arts faculty and 100 in Commerce.

#### **ELIGIBILITY CONDITIONS**

#### For 1st Year Students Minimum Percentage of Marks Required and Age Limit:

- (i) A candidate must have passed+2 from a recognized Board/University established by Law in India with English as compulsory subject.
- (ii) Maximum age limit for admission to BA/BSc/BCom. course is 23 years for general category, 25 years for girl candidates and 24 years for SC/ST category candidates, as on the 1st of July of the year concerned.
- (iii) The Vice-Chancellor, HPU may, in exceptional cases/circumstances (to be recorded in writing), give relaxation in age up to a maximum of six months to any candidate. All such cases of age relaxation of up to six months may be granted admission provisionally by the Principal, and a consolidated list of all such cases will be sent for approval of the Vice-Chancellor by 31st October of every academic year.

- (iv) Relaxation in upper age limit is also available to physically disabled candidates.
- (v) Rounding off fraction of marks is permissible.

#### DOCUMENTS/CERTIFICATES REQUIRED AT THE TIME OF ADMISSION

- (i) Matriculation certificate for date of birth.
- (ii) 10+2 Marks sheet.
- (iii) Character certificate in original from the Head of the Institution last attended or a character certificate issued by a Gazetted Officer or the Panchayat Pradhan in the case of private candidates.
- (iv) The character certificate should have been issued within the last 6 months on the day of submission of admission form.
- v) Candidates who have passed +2 from Boards other than H.P. Board of School Education/ICSE/CBSE must submit equivalent eligibility certificate from H.P. Board/University.
- (vi) Original Migration certificate from School Boards other than H.P. Board, should also be submitted. Migration Certificate in original is to be enclosed with the H.P. University enrolment form.
- (vii) Students of B.A./B.Sc./B.Com.-1are required to upload one copy each of Matriculation & +2 certificate with the enrolment form/registration form.
- (viii) Certificate of SC/ST/OBC/IRDP from Magistrate Class I for those seeking relaxation in age/marks/fee concession.
- (ix) Any gap (latest) in the academic career of an applicant must be supported by a documentary evidence/affidavit as proof of his/her activities during the period of gap. If the gap is 3 years or more, the candidate will not be admitted.
- (x) HP Domicile Certificate for girl students.
- (xi) Admission without any of these documents shall be purely provisional and at the candidate's own risk.
- (xii) After provisional admission, the candidate shall deposit the hard copy of the admission form along with all the documents / certificates prescribed, failing which, the provisional admission shall be cancelled

#### **ADMISSION PROCEDURE**

- 1. Candidates seeking admission have to fill in the admission form available online on the college website. Students must ensure that he or she has paid the prospectus fee first before filling in the form.
- 2. The candidate must fill in the admission form carefully after reading all the instructions and eligibility conditions.
- 3. After filling in the form online, the candidate has to pay the fee online by different modes available.
- 4. The college has a functional Pre-Admission Counselling Committee which guides the freshly passed 10+2 students regarding the admission procedure and the choice of subjects as per aptitude and ambition. The committee functions from the college campus itself during office hours.
- 5. All the relevant information regarding latest notices/notifications, faculty information, links are available on the college website <a href="https://gctheog.edu.in/">https://gctheog.edu.in/</a>
- 6. Change of subject is allowed only with the permission of the Principal within 10 days of the commencement of the session. Change of faculty, i.e., from Science to Arts and vice versa is permissible only if the candidate has the required percentage of marks as specified for admission to that faculty.
- 7. A candidate who has passed Prabhakar examination without passing+2 examination shall not be eligible for admission to any course in the college.
- 8. Applicant for Second year and Third year will fill up their forms online for Roll-on-Admission only after necessary notification from University/Higher Authorities

#### RULES REGARDING THE PAYMENT OF FEE

- 1. Tuition fee shall be charged for 12 months (June to May) as per schedule.
- 2. Fees should be paid (without fine) on the dates fixed by the office for each class and notified from time to time. Delay in payment will be fined accordingly.
- 3. Fee, fine and other dues once paid, will not be refunded.
- 4. Exemption of tuition fee will be available to Himachali Girls only, subject to the production of Bonafide Himachali Certificate.
- 5. Disabled students with more than 40% disability will be exempted of tuition fee, subject to the production of Disability Certificate issued by a competent Medical Authority, at the time of admission.
- 6. After the verification and online counselling of the e-admission form, the selected students being awarded provisional admission shall be sent an online fee link. It shall be the duty of the student concerned to frequently check his/her admission portal account, email account and registered phone number for any alerts. In case the student fails to deposit the fee online within the time period given, the admission offer shall be considered cancelled and given to the student next in line as per merit of the subject

#### **FINES AND PENALTIES**

- i) In case a student does not deposit his/her dues on the dates notified, their name will be struck off the roll at the end of the month.
- ii) The name of the student shall also be struck off the rolls of the college if he/she remains absent without prior intimation/approval/permission for 6 days or more continuously.
- iii) If the name of a student is struck off, s/he must be accompanied by their parent or guardian at the time of re-admission.
- iv) Every student will have to procure No-Dues Certificate from College/Library/Concerned Science Department/N.S.S./Sports/College Canteen/Fee Clerk etc. if they want to leave the college.
- v) The security deposit will lapse if a student does not apply for a refund of security within one year of his/her leaving the college.

#### Course Evaluation (Evaluation of the Students)

All courses (Core, Elective, and Skill enhancement) involve an evaluation system of students that has the following two components: -

- (i) Continuous Comprehensive Assessment (CCA) Accounting for 30% of the final grade that a student gets in a course; and
- (ii) Annual Examination Accounting for the remaining 70% of the final grade that the student gets in a course for Arts and Commerce. For Sciences and subjects/courses where practical examinations are involved, it will be 50% in Theory, 20% in Practical and 30% in CCA/CA.
- (i) Continuous Comprehensive Assesment (CCA) This would have the following components:
- (a) Classroom Attendance Each student will have to attend a minimum of 75% of Lectures/ Tutorials/Practical. A student having less than 75% attendance will not be allowed to appear in the Annual Examination.
- Provided that those having between 74% and 65% attendance will apply for exemption in a prescribed form accompanied by clear reason(s) for absence to the authorized functionaries

- Provided that those having between 64% and 50% attendance will apply for exemption in a prescribed form accompanied by a Medical Certificate from a Government Hospital.
- Provided that an exemption from 75% attendance will be given to those participating in prescribed co-curricular activities (e.g., NCC, NSS, Youth Festivals, Sports etc.) to the extent of 25% (making the necessary attendance as 50% in these cases). However, the claim for this exemption should be supported by authenticated certificates from the concerned college authorities.
- Provided further that those getting these exemptions will not be entitled to get the CCA marks for classroom attendance as given below.

Those having greater than 75% attendance will be awarded CCA marks as follows: -

75 to 79%	1 mark
80 to 84%	2 marks
85 to 89%	3 marks
90 to 94%	4 marks
95 to 100%	5 marks

- **Mid-Term (Minor)Tests** There will be one mid-term test, after covering about 70% syllabus. Mid-term tests will be for 15 marks.
- (c) Seminar/Assignment/Term Paper The remaining 10 marks of the CCE will be awarded based on seminar/assignment/term paper etc. that the course teacher might give to the students.
- (ii) Annual Examination The remaining 70% of the final grade of the student in a course will be based on an end-semester/annual examination that will be for three hours duration and will be covering the whole syllabus of the course.

The registration for the Annual exam will be done online after notification by the H.P. University, Shimla-5. The fee for the Annual exam shall be paid online.

If a student is not permitted to appear in the Annual exam due to shortage of attendance beyond the exemption limit (< 50% attendance), the candidate will repeat the year/class. A candidate failing in either one or two subjects/papers will be give compartment in these subjects/papers and will be eligible for promotion to next class. A candidate failing in three or more subjects/papers will be treated as fail in that year and must repeat the entire year.

#### LEAVE RULES FOR STUDENTS

- (i) A student can proceed on leave with prior permission from the subject teachers and the committee formed for the purpose, but the application should be signed by their parent or guardian.
- (ii) A teacher can sanction leave for up to 5 days while leave for more than 5 days will be sanctioned by the committee constituted for the purpose. Leave application must be submitted in the office.
- (iii) Leave on account of illness, if it is for more than 5 days, must be accompanied by a Medical Certificate/Hospital Registration Slip.
- (iv) Students who participate in various inter-college games or other competitions, will have to get their leave sanctioned & noted by the concerned subject teachers before their departure for participation. No exemption/leave will be granted during House Examination.
- (v) Readmission:

Students can seek re-admission only twice during the session. First re-admission will be allowed within 7 days after the name is struck off after paying fee of Rs. 100/- and fee of Rs. 200/- will be charged for the second readmission within 7 days after the name is truck off the rolls.

#### **MIGRATION**

- 1. No migration certificate can be issued unless the student is registered with the University. A migrating student will not be admitted to the college if the subjects/course studied by him/her previously are not available or not in combination decided by the college.
- 2. The migrating student must submit the following documents/information:
  - i) Lecture Attendance Statement (of all subjects offered)
  - ii) Statement of Credit earned by the student under CCA.
  - iii) Character Certificate from the Principal of the college last attended.
- 3. After migration has been sanctioned and notified by the H.P. University, the student must join the second college within the time stipulated by the University.
- 4. The admission of a student migrating from another university shall be treated as provisional and shall be confirmed when he/she produces the migration certificate issued by the university and a certificate of good conduct issued by the head of the institution last attended.
- 5. A student disqualified by another university shall not be given admission during the period of disqualification.

#### **IDENTITY CARD**

- (i) Identity Card is the most important document of a college student as it establishes their identity as a college student.
- (ii) It is mandatory for every student to carry their college identity card while in the college premises.
- (iii) A student without an identity card is deemed an outsider. In the event of inspection of identity card during surprise check or for any other reason, if the student is found without Identity card, he/she will be handed over to the police or as the situation may demand.
- (iv) A student is not permitted to replace their photograph on the identity card due to any reason whatsoever.
- (v) It is the personal responsibility of the student to keep their Identity card in safe custody. In case, the identity card is lost or gets misplaced, one must file an FIR to get a duplicate Identity card issued.

#### LIBRARY AND ITS RULES

The library caters to the needs of the students through its two-fold service, i.e., the Reading Room and the Issuance of books. It has a good collection of books and has different sections for textbooks and reference books.

The library subscribes to as many as 7 daily Newspapers, 15 Magazines and 3 Journals. Students are encouraged to avail the library facility during college hours on all working days.

#### Rules

- (i) Ordinarily, 2 books are issued at a time for 14 days, but the Librarian has the right to re-call the books at any time.
- (ii) Reference books are not issued.
- (iii) Books are issued on the Library-Cum-Identity Card
- (iv) In case of loss of a book, the student will have to replace the book or pay a fine in addition to the present price of the book with the permission of the Principal.
- (v) The student is responsible for the book as soon as it is issued. In case a book is defaced/damaged in any way, the book is to be replaced by them.
- (vi) Library-Cum-Identity Card will be issued by the Librarian at the time of admission.

#### **DISCIPLINE AND CONDUCT**

The Principal and the members of the teaching staff have the power to take disciplinary action against students indulging in reprehensible acts, which may lead to imposition of fine, suspension or expulsion from the college. The following acts come within the ambit of indiscipline and misconduct.

- i) Ragging in or around the college campus.
- ii) Damage to college property that includes defacement of walls, black boards, and damage tofurniture (breaking windowpanes, plucking flowers, removing notices, tempering with electrical/water fittings etc. is also a violation of discipline).
- iii) Loitering around in the campus or corridors during vacant periods causing disturbance to teaching work.
- iv) Putting up notices on the College Notice Board without proper authorization by the college authorities.
- v) Smoking, chewing of tobacco/gutkha, using of cell phones, and plying of vehicles within the college premises is strictly prohibited and any infringement may entail a fine of Rs. 100/-
- vi) The Director of Higher Education H.P. vide letter no. EDN-HE (21) B (15)/2017-V has directed that the use of Mobile Phones in the classrooms and campus of Educational Institutions will not be allowed. A particular zone will be fixed by the college authority within the campus where students will be able to use their cell phones.

#### **ANTI-RAGGING**

All students are hereby cautioned that **ragging is a criminal offence.** "Ragging includes any type of physical or mental torture inflicted by any individual or group, either by words or by conduct, which creates an apprehension in the mind of the person that he/she cannot pursue his/her studies from any mental disturbance or torture created thereby. Any person who aids or encourages such an action shall also be guilty of ragging."

Ragging in and around the college/hostel campus or on roads/approaches leading there to, is strictly prohibited. If any student is found indulging in ragging directly or indirectly, the college authorities shall be obliged **under Rule 22.17 (a) (b) (c) of H.P. University** to expel the guilty student(s) from the college/hostel and to report the matter to the police as ragging amounts to criminal offence as per the recent judgement of the Hon'ble Supreme Court of India, Hon'ble H.P. High Court and the Govt. of H.P.

#### **PUNISHMENTS**

#### THE STUDENTS INDULGING IN RAGGING WILL BE PUNISHED As Per LAW WITH:

- 1. Cancellation of admission and withholding/withdrawing scholarship and any other benefit.
- 2. Debarring from appearing in any test, examination, or any other evaluation process.
- 3. Debarring from representing the institution in any national or international tournament, youth festival etc.
- 4. Suspension from college and consequent debarring from admission to any other institution.
- 5. Fine up to Rs. 50,000/- or imprisonment up to 3 years or both.

All the students admitted to the college shall be deemed to have given the following undertaking:

"I have gone through the rules and regulations regarding ragging and discipline of the university/college, and I hereby solemnly affirm that I will not indulge in any act of ragging/indiscipline and that if am found guilty of such offences as are covered under these rules, I will have no claim against the order of rustication/expulsion from the college."

#### **NOTICE BOARD / WEBSITE**

All the students must scan the college NOTICE BOARD and the college website frequently to keep themselves aware of the latest happenings in the college. All important notices shall be uploaded here only.

#### **EXTENSION ACTIVITIES**

#### 1. College Students' Central Association (CSCA)

Every year CSCA is constituted as per the notification by Himachal Pradesh University,\ Shimla - 5. Its composition is as follows:

- a) The Principal of the college and five teachers to be nominated by the Principal.
- b) Four Office Bearers, i.e., President, Vice-President, Secretary, Joint Secretary. At present, these office bearers are nominated/selected on merit basis.
- c) Representatives are also nominated by the Principal from among the office bearers of societies/clubs/committees, outstanding students of cultural and co-curricular activities, NCC cadets, NSS volunteers and editors of the College Magazine.

#### 2. Sports

The college offers coaching to prepare the students for participation in inter college and inter university sports championships in Basketball, Volleyball, Kabaddi, Badminton, Cricket, Kho-Kho, Athletics, Cross Country and Chess.

#### 3. NSS

The National Service Scheme unit of the college works actively towards social welfare, creates social awareness, and promotes national integration under the able leadership of the experienced faculty.

#### 4. NCC

The college has an active and well organized unit of NCC which strives towards arousing the spirit of nationalism and serving the nation.

#### 5. Rovers & Rangers

The college has well organized units of Rovers (for Boys) & Rangers (for Girls) which gives an opportunity to the students to improve their personality and inculcate leadership qualities under the guidance of able teachers.

#### 6. Road Safety Club

In compliance to the Orders of the Directorate of Higher Education, Government of Himachal Pradesh, a Road Safety Club was constituted in the Government College, Theog on 18.12.2021. The main aim for the formation of the Club is to enhance the awareness about various issues of road safety among students so as to minimize accidents and loss of life on account of road accidents. Also, the students who learn about various aspects of road safety are expected to make others aware about the importance of road safety so that the message can be spread in all walks of life. In this way everybody will make road safety and its various rules a way of life.

#### 7. Cultural and Literary Activities

The Cultural Club and subject societies of the college hold inter-class competitions like quizzes, painting, poster making etc. from which the best talent is selected to represent the institution in HPU Youth Festival.

#### 8. PTA

A Parent-Teacher Association is formed in the college with the avowed objective of promoting participation of parents in the developmental activities of the college. Their presence and valuable suggestions are eagerly solicited by the staff in P.T.A. meetings. There is a General Body of P.T.A. comprising:

- (i) Parents or guardians (only those who have blood-relation with the students studying in the college).
- (ii) Teachers.
- (iii) The Principal of the College is the patron of the body.
- (iv) Every student is supposed to contribute Rs. 300/-per year towards PTA.

#### 9. Career Guidance & Placement Cell

Career Guidance Cell guides the students regarding different career prospects open to them in their respective fields. Clippings of advertisements for different posts, training programs from various newspapers are also displayed on the notice board for the benefit of students. Sometimes, resource people are also invited for lectures. This cell conducts lectures on career opportunities by the experts.

#### 10. Computer Laboratory

A well-equipped computer laboratory with 12 computers having HIMSWAN and BSNL broadband connectivity is available in the college to impart computer awareness to the students. The laboratory has been set up by the department of IT, H.P. and is managed by the laboratory staff.

#### 11. I.Q.A.C

Internal Quality Assurance Cell has been set up in the College to monitor the internal quality of the college.

Important decisions pertaining to the betterment of the college as well as students are taken by the IQAC.

#### 12. Scholarship

Scholarships are granted to the deserving students as per the rules/directions issued by the state govt. from time to time. The College offers the following Scholarships & Concessions:

- (i) Indira Gandhi Utkrisht Chattravritti Yojna Merit Scholarship
- (ii) IRDP Scholarship
- iii) Scholarship to the children of Armed Forces personnel killed/disabled in action.
- (iv) Post-Matriculation scholarship to SC/ST/OBC students.
- (v) National Merit Scholarship.

The students are directed to fill in the Scholarship forms on the National Scholarship Portal (NSP) and intimate the scholarship committee of the college along with relevant documents.

#### 13. College Magazine

The college brings out the yearly issue of its Magazine 'Vaangmayee' with unfailing regularity. Students, having a flair for writing, may submit their articles within the specified date for inclusion in the said magazine.

Each Department has its own independent society which initiates & undertakes various monthly activities such as:

(i) Seminars

(ii) Workshops

(iii) Group Discussions

(iv) Assignments

(v) Paper Reading

(vi) Quiz Competition

(vii) Field activities, etc.

#### **Composition of Subject Societies:**

- 1. President Head of the Department
- 2. Secretary Elected/Nominated Student
- 3. Members All students of the subject

Various Subject Societies are further grouped & each group organizes an academic function once a year.

#### 15. Membership of Clubs and Societies

Each student of the college will be a member of at least two clubs/societies. All students are, by default, members of the subject society of their first subject (DSC-I)/Major subject. In addition, students must enroll as members of any one/more of the other club in the college. This membership is to be indicated on the Identity-card of the students. It is binding on them to attend the activities of the clubs/societies they belong to and to have their attendance marked.

#### 16. Educational Tours & Excursions

The college allows various educational tours, excursions, and picnics during the session, provided the students adhere to certain conditions:

- (i) No educational tour or excursion can be organized without a teacher and without the prior permission of the Principal.
- (ii) Excursions will not be of more than three days.
- (iii) A written consent signed by either father or mother is to be submitted in the office before a student goes for a picnic/excursion /tour.

#### 17. Mentor Groups

Each student of the college will be assigned a mentor, who is a faculty member of the college. Mentors will meet their mentees once every month, on a fixed day (allotted in the timetable) to devote individual attention to their mentees. Mentors will provide guidance and will be academic and personal advisors to their mentees. It is mandatory for students to meet their mentors during the scheduled interactions.

#### 18. Tutorial Group

Tutorial groups are formed at the beginning of each academic session to facilitate better interaction between the teacher and the student. Tutorial hours are assigned per week for remedial lessons.

A well-equipped Computer Laboratory with 12 computers having HIMSWAN connectivity is available in the college to generate computer awareness among college students. The laboratory has been set up by the Department of IT, HP. and is managed by the laboratory staff.

#### 19. Annual Prize Distribution

Prizes are awarded during the Annual Prize Distribution Function for obtaining first, second & third positions in the aggregate and also for notching First & Second positions in the individual subjects in the Annual as Well as Mid Term Tests, provided a student has:

- (i) Passed in all the subjects offered.
- (ii) Obtained a minimum of 50% marks in aggregate and in the subject in which the prize is claimed. Apart from academic prizes, outstanding performers in sports, NSS, NCC, Rangers & Rovers and Cultural Activities are also felicitated.
